WHAT DOES THE FUND INVEST IN?

HOW RISKY IS IT?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk Rating

Marquest Asset Management Inc. has rated the volatility of this fund as **high**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

HOW HAS THE FUND PERFORMED?

Year-by-year returns

This chart shows how Marquest Mutual Funds Inc. - Explorer Series Fund – Series F shares of the fund performed in each of the past 10 calendar years. The fund dropped in value in 6 of the 10 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.

Average return

As at November 30, 2023 a person who invested \$1,000 in this series at November 30, 2013 now has \$489. This works out to an annual compound return of -6.90%.

WHO IS THIS FUND FOR?

Investors who:

- With a medium to long-term investment horizon with a high risk tolerance

A WORD ABOUT TAX

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

HOW MUCH DOES IT COST?

2. Fund Expenses

As of June 30, 2023, the series' expenses were 5.27% of its value. This equals \$52.70 for every \$1,000 invested.
